Now this indenture witness as follows:-

- 1) That in order to effectuate his aforesaid desire the settlor has set apart and handed over to the Trustees a sum of Rs. 6000/- (Rupees Six Thousand Only) and a office building of rent for pursuing Trust work (hereinafter called the Trust Fund which expression shall include cash and any other property or investment of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hand by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the Trustees shall hold and stand possessed of the same upon the Trust subject to the possessed of the same upon the Trust subject to the powers, provisions, agreement and declarations hereinafter contained.
- 2) That the name of the Trust shall be "ACN EDUCATIONAL & CHARITABLE TRUST". It shall be non-government and non-profit making trust. It shall be a self governing body.
- 3) Its office shall for the be situated at ACN HOUSE, 3A, NEW VISHWAS NAGAR, 18 QTR. CHOWK, DELHI., such place or places as the Trustees may decide from time to time.

49) To establish, run, support and grant aid/or others financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, Museums, research and other institutions including institute for religious education like Maths, Madrasahs, etc. of the like nature in India, specializing in Shakespeare world drama and the performing arts.

50) To take the school children for a forestation (Planting Trees) in the hills, preserve environment, cleaning of the rivers & reservoirs, take school children for rafting, educational tours etc.

- 101) To receive financial and non-financial assistance from Govt. Non-Govt. organization, International Agencies, Banks and any other legal entity or individual.
- 102) To accept donation, grants, presents, gifts, and other offerings in the shape of movable/immovable properties for the attainment of the aims and objects of the Trust.
- 103) To purchase/acquire the land and/or building in the name of the Trust for the upliftment and fulfillment of the aims and objects of the Trust.
- 104) To hold and manage the assets and properties acquired/inherited or purchased by the Trust as may be necessary or appropriate for the achievement of the objectives of the Trust.
- 105) To erect, construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop, manage and control all or any part of property or building of the above Trust, necessary or convenient for the purpose of the attainment of the aims and objects of the Trust.
- 106) To publish Book, Charts, Illustrations, Journals, Magazines, periodicals, New letters/papers and other publication in the different languages and on the different subjects.
- 107) To assist and co-operate the other Association, Trust and the various N.G.Os whose aims are same like this Trust.
- 108) To do such other things/acts/activities, which are necessary and which may be incidental or conducive to the attainment of any of the objects of the trust.
- 109) To activities and the branches shall spread all over in India and also in the different countries of World, where the Trust may decide from time to time.
- 110) To help the general public in case of natural disaster like flood, earthquake, fire.

INCOME OF THE TRUST:

The income and property of the Trust shall be utilized solely promoting the objects of the foundation as set out in this charter. No. portion of the fund shall be directly or indirectly deserted to any other organisation or person. This would identify the Trust as Non-Profit making organisation.

That for the furtherance of the object of the Trust, the Trustees shall have the following powers:-

1. To enter into contracts, agreement and arrangement with any agencies like the government authorities, municipal local and other for the benefits or which may seem conducive to carrying out all the objects and purposes of the foundation or any of them to obtain and carry out exercise and comply with any such contracts, agreements or arrangement.
2. To invest money of the Trust of the Trust in such manner and in such investment as the Trust may in their absolute discretion from time to time deem fit so to be in conformity under the provision of any law or provision of the relevant acts of the government.
3. To purchases, hire, take on lease, land movable or immovable properties and assists any where in India accepts gifts, grants or loans on such terms and conditions and subjects to the payment of interest or conditions and subject to the payment of interest or otherwise as the Trust may consider.
4. To open an account in the name of the Trust/Institution operate and close such accounts with any bank or banks as the first Trustees may deem necessary.
5. To borrow or receive money with or without security or secured by bonds, mortgages or other securities charged on the undertaking of all or any of the assets of the Trust.
6. To borrow or receive money with or without securities or secured by bonds, mortgage, or other securities charged on the undertaking of all or any of the assets of the foundation.

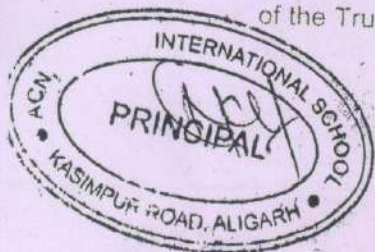

7. To sign, Endorse, transfer and negotiate all kinds of documents relating to the investment of the funds of the Trust in the interest of Trust/Security.
8. To receive money and to grant receipts and discharge thereof.
9. To transfer any funds and property of the Trust with objects or purposes whereof are similar to those of the trust and whose income is exempted from any liability by virtue of and whose income is exempted from any liability by virtue of different section related to non-profit making organisation.
10. To manage the Trust fund with life Membership, Donation & Legacy to collect and recover interest, dividends and income thereof and to pay through and out going, if any.
11. To pay or utilize the balance of such interest and dividends and income of the Trust and if the Trust so desires, to utilize the corpus of the Trust if any or part thereof for the Trust purpose.
12. To institute, defend, compound, compromise or abundant any legal proceedings by or against the Trust or its offices or otherwise concerning the assets of the Trust and also to compound and allow time for payment or satisfaction of any debt due to be paid and claims or demands by or against the Trust.
13. To engage the services of any person or persons upon such remuneration and terms as the Trust may deem fit proper to take disciplinary action against them, and also to terminate their services.
14. To delegate to any person or persons all or any of the fore going powers conjured on the Trust on in so far as they may lawfully do, subject however to the Trust retaining the ultimate control and discretion over the delegate action conduct.
15. To frame and implement from time to time rules and regulation for the administration of the Trust fund and carrying out of all/any of the Trust on purpose.
16. To do all such things as may be necessary for the effective functioning of the Trust.
17. The Trustee will not entitled to receive any remuneration, by the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or there duties relating thereof.
18. The number of the Trustees shall not be less than two and more than seven.
19. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
20. To establish, promote, manage, organize or maintain or to assist in establishing promoting, managing, organising or maintaining any branch of the Trust or like minded organisation, Institution, Trust.

RULES AND REGULATIONS

These rules shall be called the rules of the India International Center for Community Development which shall herein after be referred to as the Rules of the Trust.

DEFINITION:-

- a) Authorities means the authorities of the Trust.
- b) Government means the government of the Countries.
- c) Chairman mean the Managing Trustee of the Trust.
- d) Director mean the Director of the Trust.
- e) Board of Management means the Board of Management of the Trust.
- f) Year means the financial year.
- g) Planning Committee means of the Planning Committee of the Trust.
- h) Finance Committee means of the Finance Committee of the Trust.
- i) Advisory Committee means of the Advisory Committee of the Trust.

The Following shall be the Authorities of the Trust

- A) One Settler including four trustee
- B) Any such other authorities as may be deemed necessary by the Board of Management form time to time.

First Board of Management shall consist of

- a) The settlor of Trust will be whole life member (President).
- b) Mrs. Noorjahan Begum W/o Late Mubarak Ali (Vice President)
- c) Mrs. Raisa Chaudhary W/o Sh. R.A. Chaudhary (Managing Trustee)
- d) Mr. Zeeshan Ali Chaudhary S/o Mr. R.A. Chaudhary (Managing Trustee)
- e) Mr. Mohd Saeed S/o Mr. Ejaz Ahmed (Managing Trustee)

The founder have the powers of appointment of the Trustees. In case of retirement or death of the founder Mrs. Raisa Chaudhary will be the founder Trustee of the Trust and use all powers of the founder Trustee. In case of retirement or death of the Mrs. Raisa Chaudhary, Mr. Zeeshan Ali Chaudhary shall be founder Trustee. The founder shall be entitled to appoint any other person for the founder trustee during his /her working period.

ELECTION OF THE NOMINEES

That the founder Trustees unanimously will be selected after of his death of his legal heirs and nominees.

MEETING OF THE BOARD

- a) That Board of Management shall meet at least two times in a year time to time or found by Trust. Not less than 15 days notice shall be given of a meeting of the Board of Management. In case of urgency, the meeting may be called by Chairman by giving a notice of not less than 1 years.
- b) Each member of the above body including the Chairman shall have one vote and decision at the meeting of the Board shall be taken by majority. In case of a tie, the Chairman shall have a casting vote.
- c) Every meeting of the above body shall be prescribed over by the Chairman and in his absence member respective to preside the meeting.
- d) Any business necessary may be carried out by circulatory an appropriate resolution among its member and resolution so circulated and approved by simple majority shall be as effective and binding as if such resolution had been passed at the meeting of the Board of the Management.

POWER AND FUNCTION OF MANAGEMENT OF BOARD

The Board of Management shall be the principal executive body of the Trust and except as provided otherwise in the Rule/Bye-Laws, shall exercise all power vested in it and do all such acts and things as may be exercise or done by the Trust.

1. To manage and regulate the Finance and investments of funds, property and all other administrative affairs of the Trust and for that purpose to appoint such agent or agents as it may deem fit.
2. To entertain and adjudicate upon and if thought fit to redress any grievances of the employees.
3. To select an emblem and to have a common seal for the Trust and to provide for the custody and use of such seal
4. To Institute, fellowship, scholarship, medals and prizes on the advice of finance committee

5. To appoint such committees for such purposes and with such powers as the Board of.
6. Management may think necessary and to co-opt such persons on these committee as it think fit.
7. To appoint Auditors for the ensuing years.
8. To open account of accounts of the Trust with any more or more scheduled banks and to lay down the procedure for operating the same.
9. To issue appeals for funds consistent with the object of the Trust, to receive grants, donations, contribution gift, prizes, scholarship and other money to give grants and donations, to award prized, scholarship etc
10. To draw, accept, make endorse discount and negotiable promissory notes, bills of exchange, cheques etc.
11. To transfer or accept any movable/immovable property on behalf of the Trust.
12. To provide building or buildings, premises, furniture, fitting, equipments, appliances and other facilities required for carrying on the work of the trust
13. To deposit all moneys and credited to the fund in schedule bank/banks or to invest them in consultation with the finance committee
14. To maintain proper accounts and other relevant record and prepare annual statement of account of every previous financial year, in such form as may be prescribed by the Regulations/by laws.
15. To delegate all or any of its powers to any committee constituted by it or agent/agents etc.

FUNDS ACCOUNTS, AUDIT

- A. The account of Trust shall be maintained in the name of the Trust. The accounts of the Trust shall be kept in such forms as may be laid down by the Board of the Management. It shall conform to the Rules, if any prescribed by the respective governments. Wherever the accounts are opened and maintained.
- B. The funds of the Trust shall be utilized solely for the purpose of the Trust.
- C. Annual report and the audit reports shall be submitted to the Board of Management within three months of the closure of the accounting year for the needful.

BANKING NORMS

Founder Trustees member of the Trust or Chairman of the Board of Management with One Trustees member shall operate bank accounts norms.

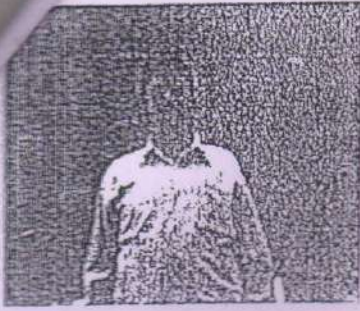

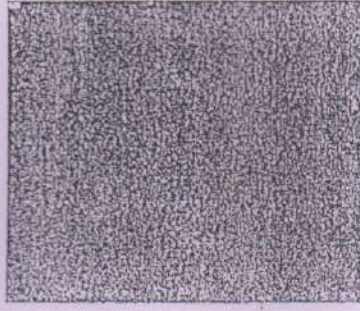


